Applications are invited for the following post tenable at TIFR, Mumbai.

### **CONSULTANT (CIVIL):**

#### **Qualification:**

- (a) M.E. (Civil Engineering) from a reputed College / Institute.

#### **Eligibility Criteria:**

The candidate should be well acquainted with the functioning of Central Government Ministries/Departments and shall have executed single project costing more than Rs.100 cr. Candidate should have experience in construction of project for more than 25 years and should preferably have experience in tendering and execution of work through EPC mode. Persons who have retired from the post of Chief Engineer (7 CPC Pay Level 14 or above) or equivalent posts from CPWD/DCS&EM or any other central government departments shall be given preference.

#### **Desirable Skills:**

- (a) Up to date knowledge of Government of India rules and regulations etc.  
(b) Possess good written and oral communication skills.  
(c) High integrity and commitment for working for long hours.

#### **Brief Scope of Work/Job Responsibility:**

- a) Validation of estimate submitted by Consultancy Services.  
b) Review of item description and rate of quantities.  
c) Draft specification document including specifications for new materials available in the market.  
d) Generating special condition of contract for the work specific to mode of execution.  
e) Processing and finalization of tender for the work.  
f) Daily monitoring progress of project and preparation of progress report.  
g) Checking bills submitted by the agency for payment.  
h) Preparation of report on quality and safety during execution of work.  
i) Coordination with DAE units and local authorities for the project.  
j) Any other matter referred to him by Chief, Engineer, TSR/EIC/Apex committee.

#### **Nature of Appointment:**

- (a) The appointment is full time and will be purely on contract basis.  
(b) The contract would be for a period of one year.  
(c) The selected candidate should have own accommodation in and around Mumbai. No accommodation or HRA will be provided by TIFR.



**Consolidated Pay:** Last pay drawn minus pension subject to maximum limit of Rs.90000/- p.m. (Rupees ninety thousand per month).

**Age Limit:** Candidate should not be more than 65 years of age on 1<sup>st</sup> May 2023.

**Leave and Travelling Allowance:** The selected candidate shall be entitled for casual leave as per Institute leave rules and not entitled for travelling allowance.
